1. Linda Sutton read the Therefore clauses of the resolution "Restrict first use of nuclear weapons and require congressional approval." David Tonkin made a friendly amendment to change the word "platform" to the word "plank" in line 5, and in line 47, to amend to read "Foreign Affairs plank of the Party platform." Linda Sutton accepted the friendly amendment. It was moved and seconded to adopt this resolution. M/S/C.

Restrict First Use of Nuclear Weapons and Require Congressional Approval

WHEREAS the foreign policy plank (approved David Tonkin) <del>platform-</del>of the Washington State Democratic Party platform begins: "We

must not conduct preemptive war and make diplomacy and nonviolent conflict resolution the primary organizing principle of foreign policy";

WHEREAS the Constitution of the United States, Article 1, Section 8 states: "Congress shall have the power... to declare War...";

WHEREAS the President currently has sole authority to launch a first-use nuclear strike, a policy

13 that increases the risk of nuclear war and is vulnerable to accidents and miscommunication:

15 WHEREAS there are over 15,000 nuclear weapons globally, most possessed by the United
16 States and Russia, many significantly more destructive than those used by the U.S. in Hiroshima and 17
Nagasaki;

19 WHEREAS use and detonation of even a small number of nuclear weapons would have
20 catastrophic human, environmental, and economic consequences globally;
21
22 WHEREAS Jefferson County's proximity to Seattle as well as major military installations puts it
23 at great risk for any nuclear strike in the Northwest;

25 President Donald Trump has called for a major buildup of nuclear weapons, which
26 will incite other countries to do the same and dramatically increase the risks of nuclear war; and
27
28 WHEREAS the United States is on track to spend \$1 trillion over the next 30 years to upgrade its
29 nuclear arsenal.

31 THEREFORE BE IT RESOLVED that the Jefferson County Democrats condemn President
32 Trump's reckless agenda that makes us targets of nuclear war
33
34 THEREFORE BE IT FURTHER RESOLVED that Jefferson County Democrats support the
35 Restricting First Use of Nuclear Weapons ACT of 2017 (H.R. 669 and S. 200) that would
36 prevent the President from unilaterally launching a nuclear first strike without a Congressional
37 Declaration of War Authorization;

39 THEREFORE BE IT FURTHER RESOLVED that the Jefferson County Democrats call on our
40 legislators, Representative Kilmer and Senators Murray and Cantwell, to publicly reject
41 President Trump's nuclear agenda and to support H.R. 669 and S. 200 by co-sponsoring this
42 legislation; and

44 THEREFORE BE IT FINALLY RESOLVED that the Jefferson County Democrats urge the
45 Washington State Democratic Party to call on the Washington State Congressional delegation to
46 co-sponsor H.R. 669/S. 200 and ask that this issue be considered as an addition to the Foreign Affairs
47 Foreign Affairs plank of the Party platform.

"Eliminate superdelegates from any role at the Democratic National Convention." Patricia Walat moved to adopt the resolution. David Tonkin moved to amend Line 26 to correct the subsection 4(g) to subsection 4(h). Patricia Walat accepted David Tonkin's motion as a friendly amendment. David Johnson moved to add "and not replace it with a similar article giving similar powers to another body" at the end of Line 33. Patricia Walat accepted David Johnson's motion as a friendly amendment. M/S/C.

Eliminating Superdelegates from any role at the Democratic National Convention 1 2 Eliminate Superdelegates From Any Role 3 at the Democratic National Convention 4 6 WHEREAS the role of superdelegates (i.e. unpledged delegates who are considered party leaders 7 not chosen by the voters to be delegates to the Democratic National Convention) is undemocratic 8 because as of 2016 the roughly 720 superdelegates represent 15% of the overall delegate count 9 (about 4,770) and are 30% of the majority needed to win the nomination (2383 currently); 11 WHEREAS the superdelegates are not representative of the Democratic Party because 6 in 10 12 are men, close to 2/3 are white, and their average age is around 60; 14 WHEREAS these delegates can swing the selection of a presidential nominee to whomever they 15 want with no regard to the choice of the voters and their choice in the primary by publically 16 supporting a candidate during the campaign and by voting for the candidate of their choice on the 17 first ballot at the Democratic National Convention: 19 WHEREAS the Democratic Party created superdelegates in 1982 to insure that a popular 20 presidential candidate that the Party leaders consider unelectable does not become the nominee; 22 WHEREAS the results of elections during presidential election years over the last 50 years prove 23 that the outcomes are unrelated to whether the nominee was chosen primarily by party insiders or 24 voters; and

26 WHEREAS Article 2, sub-section 4(g) (h) of the Cha	arter of the Democratic Party of the United
